Use this form to apply for one, two or three shows. Enclose one set of slides or photographs, a résumé, and one check. The handling fee for one, two or three shows is \$20. The booth deposit is \$50 per show. Deposits are non-refundable only on contracts you do not complete. The check total for one show is \$70; for two shows, \$120; for three shows, \$170. Include an additional \$20 handling fee for each set of additional images by the same artist if you are jurying in more than one category.

By submitting the photographs, you consent to their use in public relations and advertising promoting the Contemporary Crafts Markets. The applicant certifies that models in photos have signed releases to allow such use. Photographer credit will be given if listed on the photograph or slide. Copyrighted photos: Include a letter giving permission to duplicate or they cannot be used for PR.

Contracts are mailed about four months before each show. The balance of the booth fee will be due within 30 days after contracts are mailed.

Booth Size/Cost: Indicate for each show your 1st, 2nd and 3rd choices and if you desire a corner booth. The first measurement is the front, the second, the side. Fort Mason has no tent booths.
